<b>PRODUCTS AND MATERIALS:</b>	<p>The roof drainage system is made of continuously galvanised and colour coated sheet steel, or alternatively aluminium-zinc coated sheet steel.</p> <p><b>Gutters and pipes in standard colours:</b> Manufactured in 0.6 mm DX52+Z275 sheet steel with a 35 µm GreenCoat RWS colour coating on the front and reverse.</p> <p><b>Accessories in standard colours:</b> Manufactured in 0.6 mm DX54+Z275 and 1.0 mm DX54+Z275 sheet steel with a 35 µm GreenCoat RWS colour coating on the front and reverse. (Zink layer Z275 = 275g/m<sup>2</sup>)</p> <p><b>Gutters and pipes with an aluminium-zinc coating:</b> Manufactured in 0.6 mm DX52+AZ185 sheet steel.</p> <p><b>Accessories with an aluminium-zinc coating:</b> Manufactured in 0.6 mm DX54+AZ185 and 1.0 mm DX54+AZ185 sheet steel. (Aluminium-zinc layer AZ185 = 185g/m<sup>2</sup>)</p> <p><b>Brackets and quick brackets in standard colours:</b> Manufactured in ST-22 and ST-37 galvanised steel (Z275) with a minimum 60 µm powder coating on the front and reverse.</p>
